The Board received a Notice of Decision from the Zoning Board of Adjustment for case number 22-04-V for 340 Route 16B for owner Maurice Bishop Rev. Trust. Representing Agent is Jim Rines of White Mountain Survey, a division of Horizon Engineering. They have been granted a variance to construct a 60 ft x 120 ft commercial building within 15 ft of the front setback and to make site improvements within 100 ft of the right-of-way boundary. This will be on file in the Selectmen's Office.

The Board received a Notice of Decision from the Zoning Board of Adjustment for case number 22-03-V for 1650 Route 16 for owner Coleman P. McDonough Construction Corporation. Representing Agent is Wayne Morrill of Jones & Beach Engineering. They have been granted a variance for a storage unit development with 55% lot coverage where 40% is the maximum allowed, with the following conditions. The removal of the Concept plan off the design plans, a plan showing a minimum of 40 feet between structures. The layout will not include any encroachment of the pavement for parking inside the structure's setbacks, and all Federal, State, and Local regulations and Approvals shall be followed. This will be on file in the Selectmen's Office.

White Horse Recovery dropped off some brochures to the Town Hall. Smith read their Mission Statement and advised that the brochures will be in the Selectmen's Office.
