Budget Review Meeting Thursday, January 2, 2020

Call to Order:

Selectman Martin called the meeting to order at 9:20 AM

Attendance by Roll Call:

Present were Selectmen Sandra Martin, Martha Eldridge and Susan Simpson.

Meeting Minutes:

The Board reviewed the budget worksheet for the Conservation Agent for 2020. Requested amount is \$4,306.00 and is based on approximately 3 hours per week at \$25/hour for the Timber Monitor. Martin made a motion to approve. Eldridge seconded. A unanimous vote was taken.

The Board reviewed the budget worksheet for the Board of Selectmen for 2020. Requested amount is level funded at \$19,920.00. Martin made a motion to approve. Eldridge seconded. A unanimous vote was taken.

The Board reviewed the budget worksheet for the Ossipee Lake Dam Authority for 2020. Requested amount is \$8,212.00 and is increased from last year due to snow removal. Simpson made a motion to approve. Martin seconded. A unanimous vote was taken.

The Board reviewed the budget worksheet for the Legal Expenses for 2020. Requested amount is level funded at \$35,000.00. Budget includes legal fees paid to the Town Attorney, DTC Lawyers representing the Town in the Fairpoint Communications Tax Appeal (2014-current)and in negotiations with Charter Communications (Spectrum Cable) for the cable franchise agreement. Martin made a motion to approve. Eldridge seconded. A unanimous vote was taken.

The Board reviewed the budget worksheet for Patriotic Purposes for 2020. Requested amount is level funded at \$2,000.00 for the replacement of military service grave markers and flags in Town Cemeteries. Eldridge made a motion to approve. Simpson seconded. A unanimous vote was taken.

The Board reviewed the budget worksheet for Cemeteries for 2020. Requested amount is level funded at \$39,310.00 Eldridge made a motion to approve. Martin seconded. A unanimous vote was taken.

The Board reviewed the budget worksheet for the Planning Board for 2020. Requested amount is \$37,598.00. Simpson made a motion to approve. Martin seconded. A unanimous vote was taken.

The Board reviewed the budget worksheet for the Zoning Board of Adjustment for 2020. Requested amount is \$18,949.00. Martin made a motion to approve. Eldridge seconded. A unanimous vote was taken.

The Board reviewed the budget worksheet for Insurance for 2020. Rates will not be determined until after the budget has been reviewed by the Selectmen and the Budget Committee. The figures were adjusted to more accurately show actual expenditures of the various insurances. It was calculated just below 3% based on trends. Total requested amount is \$128,000.00. Martin made a motion to approve. Eldridge seconded. A unanimous vote was taken.

The Board reviewed the budget worksheet for the Library for 2020. Total requested amount is at \$235,957.39. Martin made a motion to approve. Eldridge seconded. A unanimous vote was taken.

The Board reviewed the budget worksheet for the Fire Warden for 2020. Total requested amount is level funded at \$21,955.00. Eldridge made a motion to approve. Martin seconded. A unanimous vote was taken.

The Board reviewed the budget worksheet for Ambulance for 2020. Total requested amount is to fulfill the existing ambulance contract due to expire 3/31/2020. Additional money will be raised in the warrant article that ratifies the new ambulance contract. The requested amount is at \$66,735.00. Martin made a motion to approve. Simpson seconded. A unanimous vote was taken.

The Board reviewed the budget worksheet for Water/Sewer for 2020. Total requested amount for Water is \$244,269.40. Martin made a motion to approve. Simpson seconded. A unanimous vote was taken. Total requested amount for Sewer is \$173,872.10. Martin made a motion to approve. Simpson seconded. A unanimous vote was taken.

Being no further input, Eldridge made a motion to adjourn. Martin seconded. A unanimous vote was taken.
