## Accounts Payable & Payroll Manifest:

#### Review of Red Folder:

The Board has issued a Notice of Tax Deeded Property for sale, acquired by a Tax Collector's Deed. The details were read into record. The property is located at 46 Stoneview Rd. Map 272, Lot 015. This is a competitive sealed bid process to be submitted to the Selectmen's Office. The bidding window is from April 25, 2022-May 23, 2022. This will be a cash sale only with the property being conveyed subject to the condition that by November 30, 2022, the structures on the property be razed and removed or restored such that the Town considers the structures habitable.
