# Selectmen's Meeting Monday, November 18, 2019

These minutes were recorded by Angela Rizzitano, Secretary. The meeting was held in the Bub Avery Memorial Gymnasium at Town Hall.

#### Call to Order:

Selectman Martin called the meeting to order at 4:15 PM. Martin opened the meeting with the Pledge of Allegiance.

## Attendance by Roll Call:

Present were Selectmen Sandra Martin, Martha Eldridge and Susan Simpson.

# **Department Head Reporting:**

Highway Department – William Eldridge, Highway Supervisor, advised that they got the F550 back and it is ready to go for the winter. He read the highway work log. Truck 7 has been sent to Rochester for repair. The sidewalks are finished. Martin asked how the conference was that Eldridge attended on Wednesday November 13, 2019. Eldridge advised it was very good and he learned a lot.

Recreation Department – Craig Brady, Recreation Director, reported that registration for the following programs open 11/19/2019. Travel basketball for children in grades 1 and 2 will be held on Tuesday's. Court Sports for children in grades 5 and 6 will be held on Wednesday's. Basketball for children in grades 3 and 4 will be held on Thursday's. He also advised that registration for the Junior Ski Program for children in grades 1 through 3 at King Pine is also open. He reported that on Monday, November 25, 2019, there will be a Skywatch with the New Hampshire Astronomy Society from 7-8 PM at the Town Hall. On Tuesday, November 26, 2019, there will be a Snow Machine Safety Class for children 11 years old or older also at the Town Hall. On Wednesday, November 27, 2019, there will be a magic show with BJ Hickman from 10-11 AM in the Town Hall gym.

Selectmen's Office – Chairman Martin reported that the office has been hard at work taking applications for open positions in the Town. Martin reported that the Town of Ossipee has hired Matthew T. Sawyer Jr. as the new Town Administrator. He will start on December 2, 2019.

Town Clerk/Tax Collector – Kellie Skehan, Town Clerk/Tax Collector, reported that the Tax Collector received approximately \$13,000.00 in Auto renewal revenue. She advised that the new tax rate is out. She advised they received approximately \$63,000.00 in pre-paid revenue and \$15,000.00 since the bills have been printed. They will be mailed November 19, 2019 and due on December 26, 2019. The tax rate is as follows.

Center Ossipee-\$18.51 Ossipee Corner-\$19.28 West Ossipee-\$19.01 Transfer Station – Brewster Vittum, Transfer Station Supervisor, advised that they had 5 bales of recycling. Vittum also advised they shipped out a tractor trailer load of electronics. Martin asked if they have been busy. Vittum advised they are still getting a lot of construction debris.

Water & Sewer Department – Wayne Eldridge, Water & Sewer Supervisor, reported that he fixed a major water leak in Arrowhead and helped with a sewer problem. Nothing further to report.

Zoning Enforcement/Government Buildings – Steve McConarty, Zoning Enforcement Officer, reported he has been busy with permits. There are a lot of additions in progress as well as new homes being built and commercial as well. He also advised that Westward Shores will be installing an indoor pool house. McConarty advised that O'Reilly's Auto Parts should be open in about a month.

## **Public Input:**

Ash Fischbein thanked the Highway Department for their hard work on the sidewalk project. He asked if we had a cost average for typical sidewalks and the Town fell on that scale. Martin advised that Karen Anthony, Finance and Benefits Director, is working on putting it together. Ash Fischbein also asked the Board to appoint Joy and Gary Gagnon as representatives for Carroll County Broadband.
