Article #1 - 5 were not read.

**Article 6#** To see if the Town will vote to raise and appropriate the sum of three hundred thousand dollars (\$300,000) for the purpose of repair and improvements of Town roads. (Recommended by the Selectmen 3-0) (Recommended by the Budget Committee 7-0) (Majority vote required)

**Article 7#** To see if the Town will vote to raise and appropriate the sum of twenty thousand dollars (\$20,000) to be added to the Highway Equipment Capital Reserve Fund previously established. (Recommended by the Selectmen 3-0) (Recommended by the Budget Committee 7-0) (Majority vote required)

**Article 8#** To see if the Town will vote to create an expendable trust fund under the provisions of RSA 31:19-a, to be known as the Government Buildings Improvements Expendable Trust Fund for the planning, construction and related expenses to improve Government facilities in the Town of Ossipee and to raise and appropriate the sum of twenty thousand dollars (\$20,000) to be placed in said fund, and to designate the Selectmen as agents to expend. **Article #16** To see if the Town will vote to raise and appropriate the sum of twenty-five thousand dollars (\$25,000) for the purpose of purchasing and installing new playground equipment at Constitution Park. Article #17 To see if the Town will vote to raise and appropriate the amount of sixty-six thousand one hundred dollars (\$66,100) for the continued repairs and improvements to the Ossipee Concerned Citizens Building. (Note: \$44,420 from last year's similar article went unspent and is being returned to the general fund.) (Recommended by the Selectmen 3-0) (Recommended by the Budget Committee 7-0) (Majority vote required)

Article #18 To see if the Town will vote to purchase a baler for the Transfer Facility at the cost of seventy eight thousand five hundred dollars (\$78,500) with fifty nine thousand dollars (\$59,000) coming from the Solid Waste Improvements fund and the sum of nineteen thousand five hundred dollars (\$19,500) to come from the Unreserved Fund Balance. (Recommended by the Selectmen 3-0) (Recommended by the Budget Committee 7-0) (Majority vote required)

Article #19 To see if the Town will vote to purchase a loader for the highway department at a purchase price of one hundred sixty-one thousand eight hundred eighty-seven dollars (\$161,887), with this amount to be reduced by (\$20,000) received by trading in the old loader. Furthermore to vote to raise and appropriate one hundred forty one thousand eight hundred eighty seven dollars (\$141,887) for this purchase with funds in the amount of One hundred thousand dollars (\$100,000) to come from the Highway Equipment Capital Reserve Fund and the remainder of forty-one thousand eight hundred eighty-seven dollars (\$41,887) to come from the unassigned fund balance. No amount to be raised from taxation. (Recommended by the Selectmen 3-0) (Recommended by the Budget Committee 7-0) (Majority vote required)

Article #20 To see if the Town will vote to raise and appropriate twenty-seven thousand dollars (\$27,000) for the purchase of tactical gear for the Police Department, with funding coming from the Unreserved Fund Balance and no sum to come from taxation. (Recommended by the Selectmen 3-0) (Recommended by the Budget Committee 7-0) (Majority vote required)

Article #21 To see if the Town will vote to raise and appropriate the sum of nine thousand dollars (\$9,000) for technology improvements including replacing obsolete computers and upgrading security for the network. (Recommended by the Selectmen 3-0) (Recommended by the Budget Committee 7-0) (Majority vote required)

Article # 22 To see if the town will vote to change the purpose of the existing Ossipee Sidewalk Expendable Trust Fund to the Ossipee Sidewalk Construction and Lighting Expendable Trust Fund for the planning, layout and installation of sidewalks, sidewalk lighting, signage and related expenses in the Town of Ossipee and to designate the Selectmen as agents to expend. (Recommended by Selectmen 2-0) (Recommended by Budget Committee 7-0) (2/3 vote required).

Article #23 To see if the Town will vote to raise and appropriate the sum of nine thousand five hundred dollars (\$9,500) for resurfacing and line painting of the tennis courts at Constitution Park. (Recommended by the Selectmen 3-0) (Recommended by the Budget Committee 7-0) (Majority vote required)

Article #24 To see if the Town will vote to raise and appropriate the two hundred eighty-two thousand, two hundred forty-nine dollars (\$282,249) to contract ambulance services for 9 months of this year not covered by the previous contract. (Recommended by the Selectmen 3-0) (Recommended by the Budget Committee 7-0) (Majority vote required)

Article #25 To see if the Town will vote to enter into a five year agreement (which may include an intergovernmental agreement under RSA Chapter 53-A) with one or more ambulance service providers and/or other regional municipalities such as but not necessarily limited to the Towns of Eaton, Effingham, Freedom, Madison and Tamworth, to provide emergency medical/ambulance services. (Recommended by the Selectmen 3-0) (Recommended by the Budget Committee 7-0) (Majority vote required)

Article #26 To see if the Town will vote to raise and appropriate the sum of forty five thousand dollars (\$45,000) to replace the carpet in the Ossipee Public Library, which includes tearing up and disposal of old carpet, purchase and installation of new carpet tiles, and the expenses of moving contents to accommodate the project. (Recommended by the Selectmen 3-0) (Recommended by the Budget Committee 7-0) (Majority vote required)

**Article #27** (Submitted by Petition) A petition to see if the Town will vote to raise and appropriate the sum of five thousand dollars (\$5,000) for the Old Home Week Committee to use towards Independence Day fireworks. Question from the audience inquiring as to which road would be repaired with the \$300,000.00 in Article #6. She was informed it was not any specific road but for all roads.

A question raised in the audience of how much was last years amount to be raised by taxation. Sawyer replied \$4,246,151.00 with the Overlay amount. This year's budget amount increased by approximately \$240,000.00.

Goss noted the three substantial increases are:

- 1. Full-time Employee for the Transfer Station
- 2. Highway Dept. New Loader
- 3. New Ambulance Contract

Point of Order from Smith, who clarified the "Amount in Surplus" it's actually an "Unassigned Fund Balance." It's not money sitting in the bank. Goss noted, it's money that's tied up in unpaid taxes. Smith explained it's the difference between the Towns assets and liabilities. It's only on paper, it's not in liquid form.

Goss moved on the Fire Precincts budgets.
