Chairman Adams read an excerpt from the January 5, 2015 Ossipee Selectmen's Meeting minutes regarding the Sumner Brook solar project "Discussion took place on the requirements of the government rebate for the solar project and timeframe of the installation. Riley suggested the tenants bring in the criteria to the Board then they can discuss options with the Town Attorney. Morgan stated they are willing to work with the tenants but did see the necessity of an extension in 2015 with 5-years remaining on the current lease. Morgan requested that Adams reaffirm the Board's support to the tenants."

New Business

Chairman Adams has contacted Wendy Scribner (UNH Cooperative Extension) to determine which date she is available to present a program on invasive plants and bugs at Ossipee Public Library (March 23 or 27). Once the date is finalized, Ms. Gridley agreed to write press releases for the program.
