Motion: by Donna G., seconded by Ralph B., to approve meeting minutes of June 8, 2016. **All in favor, motion passed.**

The proposed biostabilization consists of a boulder toe backed with rip rap & native low bush blueberry plantings.

CC discussion on the effectiveness of the biostabilization technique raised concerns and questions.

Motion: by Ralph B., and seconded by Tim O., to submit a letter with the application addressing concerns of biostabilization technique being used. **All in Favor, motion passed.**

• Lake Host Program: Ron A., reports unable to make contact with Connery Dearborn after several attempts. Contact information given to Tim Otterbach for follow up. Ron L., reported per Fish & Game the ramp will be shut down for one moth beginning August 1st for repairs. Ron A., to contact Amy to discuss these concerns. Potential decision may be made not to pursue Lake Host Program for this year.

• New Business:

• Get Wild Program – **Ron A.,** spoke with Jess Cole at the Fish Hatchery and the suggested dates are August 13th or 27th for the fishing day. After discussion the CC decided on Saturday, August 13, 2016. **Ron A.,** will schedule with Jess Cole.

Motion: by Ron A., and seconded by Donna G., to spend up to \$1,500.00 for our get well program, fish, advertising and entertainment for the event. **All in favor, motion passed.**

Informational:

• Karen Payne: Ltr received July 13, 2016 concerns about WWSCG and use of Environmental Canine Services (ECS) to sniff out the bad septic systems. Donna G., reported per the Selectmen's meeting if ECS wants to use sniffer dogs ECS would have to do all the Ossipee portion of Ossipee Lake as to not discriminate against WWSCG. Tim noted that GMCG sent out questionnaires asking residents to identify if there septic's are up to current state codes but does not ask them to identify where they live. Tim also noted written permission from every homeowner would be needed and is there a governing body, who oversees existing septic systems that are on or near the lake that are within the setback zone that could come in legally and inspect.

Discussion ensued over the use of the dogs and who has authority to review businesses/properties for compliance. It was assumed the Planning Board could ask the Zoning Enforcement Officer to look into these situations but according Bruce P., over the past 6 month to a year, the PB has no authority to ask the ZEO to review anything, and it has to come from the Selectmen. Dallas Emery noted according to Zoning Ordinance 24.3 – The Board of Selectmen or its Zoning Enforcement Officer shall make inspections, as appropriate to ensure conformity with the provisions of this Ordinance.

Point of Order: Ron A., noted they were getting off topic.

The question is the CC could ask the Selectmen to pursue a program like this to determine if there is a problem with failing septic systems leaching into Ossipee Lake in order to protect our natural resources. **Motion:** by Ron L., and seconded by Tim O., to submit a letter ask the Selectmen to pursue a program like this to determine if there is a problem with failing septic systems leaching into Ossipee Lake in order to protect our natural resources and addressing the effectiveness of using Environmental Canine Services.

Discussion continued...

Ron L., withdrew his motion.

New Motion: by Donna G., and seconded by Ron L., to submit a letter to the Selectmen addressing concerns of some failing septic systems on Ossipee Lake and to pursue a program like ECS to determine if there is a problem with failing septic systems leaching into Ossipee Lake in order to protect our natural resources.

Discussion: Ron L., asked how tax revenue is generated to this town from the lake. Ron A., replied 52% of the tax revenue comes from the lake. **All other in favor. Opposed:** Ralph Buchanan.

Other business:

- PB updates on WWSCG: Bruce P., reported
 - 1. WWSCG is continued until July 19th meeting
 - 2. PB approved to have a peer review of the plans and regulations.
 - 3. WWSCG also has to apply for a Lot Merger before a final decision can be made.
 - 4. Per agreement with NH Fish & Game: a proposed conservation easement of 34 acres along Bear Camp River. North bank of Bear Camp River up to the flood way and 11 acres of the island area which forms the outlet to the Bear Camp River. Totaling 45 acres in conservation easement to be held by New England Forestry.
 - 5. On the Peninsula: Moved all campsites back to 50 ft. from water's edge. Original plan was 20 ft. from water's edge with NHDES approval.
 - 6. Reduced Peninsula campsites from 18 to 15 campsites
 - 7. Laura N., reported Dollar General's application for subdivision is scheduled for July 19th, the final SPR approval is pending 6 conditions, 1 of which is the subdivision.

Discussion ensued over moving of campers during a flood, septic system and conservation easement.

Motion: by Donna G., and seconded by Tim O., Ron A., will write a letter to the PB from the CC asking for the whole area wetlands, south west of the proposed new camp sites be put into conservation easement, not just the section along the Bear Camp River.

All in favor, motion passed. Abstained: Bruce Parson

• Windows on the Ossipee - Ralph B., submitted an official proposal for work to be done at Windows on the Ossipee. Total cost = \$1600.00 - \$600.00 (CC discount) = \$1,000.00 + \$250.00 (2 loads of gravel) = total cost \$1250.00 Ralph provided \$240.00 no charge for 3 hours of work done on June 27, 2016. Ron A., will speak with Ellen White on BID Rules.

Motion: by Ron L., and seconded by Donna G., to spend up to \$1300.00 for this project. All other's in favor. Abstained: Ralph Buchanan

- **BSA Troop 234 Eagle Scout Project:** Scout Master: Andy Northrop and Scout: Bryce Northrop proposed planning, mapping and blazing trails at the Windows on the Ossipee property. *Ron L.*, offered another property on *Beech* River.
