Selectmen's Meeting Monday, January 22, 2024

Accounts Payable & Payroll Manifest:

Veterinary Urgent Care of NH c/o Amanda Flagg & Megan Witt and owner White & Brown Dog, LLC is granted a final site plan review amendment for a Veterinary Urgent Care facility. It is on file in the Selectmen's Office.

The Board received a Notice of Decision from the Ossipee Planning Board for Case #23-09-SPR. Eric Clifford c/o Fireside Lumber is granted a final site plan review to have a 30 ft. building with front office space and storage of lumber for sale. This is on file in the Selectmen's Office.

The Board received a letter from Plozdzik & Sanderson, PA confirming the acceptance of the audit engagement. Smith made a motion to approve. M. Eldridge seconded. A unanimous vote was taken.

The Board received a letter of recognition for Bernie Dow at the Transfer Station. Smith read the letter into record. The letter expressed deep appreciation for Bernie's willingness to help others, especially the elderly. The letter asked the Board to acknowledge Bernie's exceptional service. Smith thanked Bernie on behalf of the Board.

Smith mentioned that the Town did not need to use the TAN note. He mentioned that Andrea in Finance does a great job and that it was a team effort.
