Motion: by Ron, seconded by Bob, to review and vote on August 25, 2015 meeting minutes as published. All in favor, motion passed.

- Milfoil (pulling or chemical?) Charlotte stated they were pulling but Ron A. has information that they are chemical treating.
- Monroe/Ciccotelli property No update.
- Summer Brook Property Ed Marshall was present and provided three options. Discussion ensued, the lease agreement was reviewed.

**Motion**: by Ralph, seconded by Ron A. to expend up to \$4,000 to either repair the chimney and/or put in a new heating system. If a new heating system is installed, tenants will

be responsible for the price and pay it off over a three year time period by increasing their monthly rent.

Discussion ensued.

Motion: by Ralph was withdrawn.

Further discussion ensued on options for repair.

Ron A. noted that the selectmen believe the tenants are not paying enough rent for a business and a home. Ron L. stated he is upset that the selectmen feel the way they do. Donna noted the tenants need to provide the Conservation Commission with their yearly expenditures yearly so that the selectmen can see what they are paying for out of pocket like new windows, a new roof, and putting in a new kitchen. Ron A. noted that when discussing the new lease, they should provide a business report as well.

**Motion:** by Ralph, seconded by Ron A., to remove the existing boiler and line the chimney for an amount up to \$4,722 and if the tenants want to purchase a new boiler and pay back that difference over time, that can be worked out.

Discussion ensued.

- Vote on Motion: 2 in favor (Ralph and Bob), 3 opposed (Ron L, Donna, Ron A.). Motion failed.
- **Motion:** by Ron L., seconded by Donna, to provide a new direct vent boiler (located where the contractor choses) and a new hot water for a not-to-exceed amount of \$7,352.

Discussion ensued.

- Vote on Motion: 3 in favor (Ron L, Bob, Donna), 2 opposed (Ralph and Ron), 0 abstained. Motion passed.
- Motion: by Ron A., seconded by Donna, that the tenants provide up to \$2,000 in money or sweat equity toward repairs. 4 in favor (Ron A., Ron L, Ralph, Bob), 0 opposed, 1 abstained (Donna).

Auction of Properties– Ron reviewed the properties up for auction and is hoping that Ron A. is hoping that UNH will bid on this. Guy Eaton at UNH, Facilities seemed favorable to this. Ron A. should be hearing back from Guy before the end of the week. Discussion ensued regarding other options if UNH does not bid on this.
