## August 9, 2017

Call to Order: *McConarty* called the meeting to order at 7:00 PM.

Roll Call: Marie McConarty, Ralph Buchanan, Lorey Pendarvis and James Dolan. Late: Tim Otterbach Absent: Joe Deighan

Minutes: Review to approve July 12, 2017 Minutes:

Late arrival of Tim Otterbach at 7:11 PM.

A Motion by Buchanan to accept the minutes of July 12, 2017 Meeting Minutes. Dolan seconded.

Discussion: McConarty noted one correction on page 1, under discussion of the GET WILD Event it states "Ossipee Conservation Commission – set up table with pamphlets." McConarty noted it should read, "Ossipee Conservation Commission set up tables."

A **Motion** restated by Buchanan to accept the minutes of July 12, 2017 as corrected. Dolan seconded. No discussion. A unanimous vote was taken.

- <u>Budget & Revenue Reports</u>: July 2017 Dolan raised questions about going over budget with secretary's wages and asked if the Selectmen would offset the difference.
- <u>Long Sands Association</u>: Received annual donation of \$100.00 to go towards water quality and land maintenance.

A **Motion** by McConarty to accept the donation. Otterbach seconded. No further discussion. A unanimous vote was taken.

A **Motion** by Buchanan to deposit the donation into the Conservation Commissions checking account. Otterbach seconded. No discussion. A unanimous vote was taken.

• <u>Pat Jones Stationary Cards</u> - \$12.00 received from sales of cards.

A Motion by Otterbach to accept the donation. Dolan seconded. No further discussion. A unanimous vote was taken.

A **Motion** by Otterbach to deposit the donation into the Conservation Commissions Money Market account because this is the account the original money was expensed from. Pendarvis seconded. No discussion. A unanimous vote was taken.

# New Business:

• <u>Scenic Overlook</u>: Discussion - Proposal to go out to bid for clean-up – The Commission referred to Deighan's email and geographical map he provided. Otterbach suggested a site visit to take actual measurements and see exactly what needs to be removed or cut. Discussion ensued

A **Motion** by Otterbach to send a letter to the Board of Selectmen asking for a Request For Proposal (RFP) to put out to bid the cutting and removable of small trees and brush at the Scenic Overlook. Dolan seconded.

Discussion ensued over specific footage of area to be worked. Otterbach will go down, take measurements, and send to secretary in order to write the letter to the Selectmen.

With no further discussion, McConarty called for vote on the motion. A unanimous vote was taken.

- <u>Tamworth property</u>: Leah Hart Forest Society site walk visit scheduled for Sept. 7th. Deighan and Otterbach are scheduled to attend the site walk, just pending the time.
