TOWN OF OSSIPEE CONSERVATION COMMISSION MEETING MINUTES

January 8, 2020

Minutes were recorded, and a Summary transcribed by Laura Nash, Commission Secretary. Revisions to these minutes are noted by *bold/italic* type.

<u>Call to Order</u>: Marie McConarty called the meeting to order at 7:00 PM.

Roll Call: Marie McConarty - Chair, Lorey Pendarvis and Krystal Eldridge.

Absent were: Ralph Buchanan, James Dolan, and Joe Deighan.

McConarty read a letter received on 01/08/2020 from Joe Deighan resigning from his position on the Conservation Commission.

A **Motion** by Pendarvis to accept Joe Deighan's letter of resignation from the Conservation Commission and to send him a letter thanking him for his service. Eldridge seconded. No discussion. All voted in favor. **Motion passed**.

Meeting Minutes: Review to approve December 11, 2019 Minutes.

Eldridge noted she was not in attendance at the December 11, 2019 meeting. Corrections were made to reflect the correct attendees, "Roll Call: Marie McConarty – Chair, Ralph Buchanan – Vice-Chairman, James Dolan, and Lorey Pendarvis. Absent were: Joe Deighan and Krystal Eldridge."

A **Motion** by Pendarvis to approve the meeting minutes of December 11, 2019, as amended. McConarty seconded. No discussion. Eldridge abstained. All others voted in favor. **Motion passed**.

Guest: Ned Kucera of Freedom Tri-Town Committee for the Lake Host Program. Kucera gave an update on the Lake Host program going into 2020 season. In 2019, Ossipee paid \$3,750.00 into the program. They received a Payroll Grant Funds Award for Hourly Pay in the amount of \$2,500.00, NH Lakes Funds contributions for Ossipee was \$2,716.00 and Freedom was \$4,220.00, Funds rolled over from 2018 was \$2,190.76 for a total amount of \$11,626.76. Total amount expensed for Lake Host hourly pay was \$7,194.00, thus leaving a balance of \$3,428.66 which NH Lakes will hold towards the 2020 Lake Host Program. Ossipee paid \$3,750.00 into the program. Submitted maps showing areas of infestations of variable milfoil, and Eurasian milfoil, with some being found at the Westward Shores area. Other species moving into the lakes are fanwort, water chestnut, and Chinese mystery snails have been found in Sebago Lake. They had 3 – Lake Host stationed at the Pine River, Ossipee Marina and Lord Landing for a total of 51 hours worked. For 2020, their looking for \$3,500.00 each from Ossipee and Freedom, and anyone interested in becoming a Lake Host can contact Jim McElroy or Ned Kucera at 603-539-5492 or via email ibmcelroysr@earthlink.net.

McConarty explained her discussion with the Budget Committee denying the funding through the operating budget and that the CC needs to apply for funding either through a Warrant Article or apply as an Outside Agency. McConarty conveyed some concerns from the Budget Committee that some of the transferring of invasive species is coming from the bass fishermen that are lake hopping. Since, there are no host at the boat ramp at 5:00 AM, when their launching their boats. Ned Kucera was asked to attend the Town Meeting for possibly getting it passed on the floor and was informed of the budget committee meeting taking place tomorrow night. Westward Shores contact information will be provided to Kucera for in the hopes of positioning a Lake Host at the boat ramps at Westward Shores.

Financial:

A **Motion** by McConarty to transfer \$5,000.00 from the money market account to the Conservation checking account to pay invoices from White Mtn Survey & Eng., Inc., as listed above. Pendarvis seconded. No discussion. All unanimous vote was taken. **Motion passed**.
