SSVF (SUPPORTIVE SERVICES TO VETERAN FAMILIES)

is a program through Harbor Homes, Inc. to serve NH Veteran households who are either homeless or about to become homeless (in the next 14 days)

Eligibility Requirements:

The household must be headed by a veteran who:

1. Has a minimum of **one day ACTIVE** service status (for National Guard, veteran must have been deployed for at least 24 hours, by Presidential Order)
2. Has a discharge status that is **not dishonorable**
3. **Is in economic hardship** (At least < 50% of Area Family Median Income AFMI)
4. **WITHOUT OTHER RESOURCES FOR INCOME OR HOUSING** ("but for" these monies, the veteran is homeless)
5. **Literally homeless or about to become homeless** (within 14 days)

Required Documents: * DD 214
Income Verification (pay stubs, bank statement, award letter, tax return
Housing Related documents (lease, eviction notice, utility bill, fuel bill, mortgage and foreclosure documents, etc.)
Custody agreements, other expenses related to housing (moving costs, childcare, etc.)

* In cases where client has no documentation, an affidavit is signed verifying veteran status, housing status and income.

Service description: Short Term Financial Assistance & Case Management for Veteran Family Housing Assistance – including financial assistance with housing and housing related expenses

Area served: The state of New Hampshire
