Fred is the son of the late Darcy Loud. Beverly is the daughter of the late Philip Drew. Ruth Loud, recently deceased and Frances Drew, mothers of Fred and Beverly resided at the Carroll County Nursing Home.

Beverly retired from her longtime employment with Ossipee Concerned Citizens, Inc. and Fred retired from the Town of Ossipees' Highway Department in 2007.

For over thirty years, Bev and Fred have worked separately and together on a multitude of community and agency benefits, fundraisers, and committees, to help the Town and it's people. 

March 12, 2008

Article #6 To see if the Town will vote to raise and appropriate the sum of four hundred eighty thousand dollars (\$480,000.00) (gross budget) for the replacement of the water lines along Dore Street from Moultonville Road to 51 Dore Street (the end of existing line) and to authorize the borrowing of not more than three hundred fifty thousand dollars (\$350,000.00) in the form of bonds or notes from the Department of Environmental Services Revolving Water Fund, and to authorize municipal officials to issue and negotiate such bonds or notes and to determine the rate of interest thereon, with the balance of one hundred thirty thousand dollars (\$130,000.00) to come from the Water and Sewer Department's Unreserved Fund Balance. No amount is to be raised from taxation. The Water and Sewer Department

Commissioners recommend this appropriation. (Recommended by Selectmen 2-0)
(Recommended by Budget Committee) (2/3 paper vote required)

Article #9 To see if the Town will raise and appropriate the sum of thirty thousand dollars (\$30,000.00) to add to the Capital Reserve Fund for improvements to the Solid Waste Facility, due to the required closure of the Incinerator and appoint the Board of Selectmen as agents to expend. (Recommended by Selectmen 2-0) (Recommended by Budget Committee) (Majority vote required)

Article #10 To see if the Town will raise and appropriate the sum of twenty-five thousand dollars (\$25,000.00) for the purpose of purchasing storage units and putting roofing over the recycling bins at the Solid Waste Facility. OSSIPEE ECONOMIC DEVELOPMENT COMMITTEE

2008 Annual Report

The Ossipee Economic Development Committee is scheduled to meet on the fourth Tuesday of every other month. Meetings are called as needed. New members are always welcome. Our Mission is to foster organized growth utilizing human and natural resources in a responsible way. The OEDC seeks to educate and involve the community in its work.

The OEDC members are involved in projects in the Mount Washington Valley Economic Council. OEDC member Donna Sargent is Ossipee's representative on the Council. She is a member of the Revolving Loan Fund Committee. Ossipee residents who would like to start or expand a business are encouraged to apply for a loan. SCORE volunteers are available to help with business plans. The Technology Village is also home to the Granite State College, the White Mountains Community College, and Plymouth State University offering courses to help education and career advancement.

Members of the Ossipee Economic Development Committee have attended programs presented by leaders in the business, government, education and financial sectors of our economy. Several have attended conferences and seminars to learn more about how to revitalize downtown Center Ossipee.

Most of the OEDC members interested in the concept of business revitalization with historic preservation while building a feeling of community, formed the Ossipee Revitalization Group, dedicated to attaining Main Street membership. Ossipee has now been a Main Street Community for several years. The program basically consists of volunteers working in structured task-oriented committees to improve the vitality of their community. One of the four committees is the Economic Restructuring Committee, which is sponsoring the fourth annual Economic Fair at the end of March that the OEDC is pleased to help sponsor. The first three Economic Fairs were a big success. Last year one of the interesting mini-workshops dealt with taking courses over the internet. Many of the presenters plan to return, and several new free workshop sessions are being added. New this year, there will be an energy conservation component to the Economic Expo and SCORE representatives will be available.


Summer Reading Program 2008 "G'Day for Reading," an Australian theme sponsored by Chilis/NHLA:

Registration began on June 23, 2008. **Eighty-five children registered.**

The Portland Sea Dogs donated 75 vouchers for game tickets, which library staff members handed out to each child who registered along with a reading log.

On July first at 10:30am, the summer reading program "kick-off" took place at the town hall with The Wildlife Encounters Zoo, sponsored by The Old Home Week Committee, the Friends of the Ossipee Public Library, and the Governor Wentworth Arts Council. Derek Small (pictured) who founded Wildlife Encounters Zoo in 2004 brought several creatures to represent the Australian theme: a monitor lizard, a cock-a-too, a python, a green tree frog, a glider, and a wallaby. **About 500 people attended the event.**

During the six-week program, the library held two story times with activities each week. On the first week, Polly Sheffer read stories about marsupials and each child colored a die-cut kangaroo with a baby in the pouch. On week 2, Polly read about Australia and had the children make a collage with magazine cut outs of



Australian landscapes, animals, reptiles, etc. The children decorated plastic boomerangs on the third week. On the 4th week, Lesa Gauthier came to the library with her spinning wheel and did a fiber demonstration. She brought in pieces of wool from her own sheep and showed the children how to spin yarn. She also brought some finished products that she had knitted to show the children how yarn is made into hats, mittens, scarves, sweaters, etc. (Sheep are a big part of Australia's livelihood). On the last week, the children listened to Anne Martin-Segrini read about the Australian instrument called the didgeridoo. The children decorated their own didgeridoos and played them. (Skehan's Lumber donated PVC pipe to the library for the instruments, and Steve Sheffer cut the PVC into 3-foot lengths and sanded the ends).

Fifty children returned their reading logs and many participated in "prize" day on August 14th.

Statistics:

85 children registered.

50 children returned reading logs. (A total of 900 books read).

30,388 minutes read (collective total).

The top three readers were: first, Bryce Northrop at 3,961 minutes read/recorded; second, AJ Lavoie with 3,120 minutes; and third, Madison Lavoie with 2,010 minutes.

Eight readers read over 1,000 minutes each.

*** Squam Lakes Natural Science Center, in Holderness, NH.** We received two free admissions, plus up to four additional discounted trail admissions for \$7.00 each. From May first to November first.

*** Wright Museum, Wolfeboro, NH.** We received two free passes. Each pass admits two Adults and four Children (under 18 years of age) free of charge. Both Library passes are sponsored by James Rines, of the White Mountain Survey Company.

*** Ossipee Public Library Baby Book Bag Program:** Each baby born to Ossipee residents will receive a library book bag containing one or more books and a stuffed doll or animal. This gift was made possible through a library grant received from the Ossipee Rotary Club, a Friends grant received from Believe in Books Literacy Foundation and the Friends of the Ossipee Public Library.

***Kindergarten Book Bag Program:** Each year when a kindergarten child is registered at the Ossipee Central School, he/she will receive an "Ossipee Public Library" forest green canvas bag filled with an age appropriate book and an application card for the public library in memory of Catherine Ziegler. This gift was made possible through the donations from family and friends in loving memory of Cathy.

***Genealogy Section:** The Family History area of the library has grown with over 100 family histories on a dedicated computer in the reference room. These are all early Ossipee families and can be accessed by anyone doing genealogy research. We also have a number of published works that include Ossipee families. To augment this, the general research material of genealogy has grown and it has been said by researchers who come great distances to find their Carroll County and

Ossipee roots that we have the best-organized collection of research material in the county. Those with a Canadian connection may find their link in newly acquired material that includes early families of Canada.

***The Friends of the Ossipee Public Library** held several fundraisers throughout the year. They sold book bags and notebooks, and held a Feaster's Fantasy raffle in the summer. With these funds the Friends paid to have new wiring and light fixtures installed in the book cellar. The Book Cellar is operated by the Friends every Saturday during the summer, and the first Saturday of the month during the rest of the year. The Friends enjoy decorating the library for the holidays. They continue to fund most of our programs, including some of the prizes given to all participants in the summer reading program. The Friends are always happy to welcome new members.

*** Artwork on display in the meeting room:** Natalie Peterson, Peter Abata with twelve other artists from neighboring towns, Peggy Brewster, the children from the Summer Reading Program with Australian artwork (G'day for Reading), Nancy Curtiss and Carol Aiton, all generously shared their work.

* The Meeting Room is often used to offer educational, historical, civic, Scout and cultural programs to the community. The library also continues to sponsor a wide variety of programs:

- AARP volunteers provide tax assistance from February to June.
 - Our book discussion group meets the first Tuesday afternoon of each month, at 2:00pm.
 - Ossipee Garden Club meets the first Thursday afternoon at 1:00 pm.
 - Quilters group meets the second and fourth Tuesday evenings at 6:30 pm.
- The quilters are in the process of making a quilt as a fundraiser for the library.

- Story-time for pre-school children continues to be held on Tuesday mornings at 10:30 am. Story-time for babies is held on Friday mornings at 10:30 am.

- Book delivery and pick-up of books, video, audiotapes and other library materials are available for the homebound. The library also stocks large-print books and the Reader's Digest magazine for visually impaired readers.

(These programs are open to everyone)

***New improvements to the Library:** The original section of the library received all new wiring. Additions were made to the alarm system from Lakeside Security and a new railing at the back of the library.

* Once again, our appreciation and gratitude go to a large group of wonderful people who give of themselves, through their time and donations, to enrich the lives



of others. They make your library what it is today.

* The trustees and library staff wish to thank the citizens of Ossipee for their on-going support. We look forward to another successful year of growth and service.

The Whittier Bridge has been removed from its location on the Bear Camp River and is now in dry dock for the next stage of restoration. I would like to give a great amount of credit to Bob Gillette and his committee that made this all happen.

This year saw the retirement of Richard Morgan as the Chief of Police and the appointment of Sergeant Donald F. Grow as the new Chief. Due to the retirement of Rick Morgan and Kevin O'Meara, the Town hired three new officers to the Police Department. We would like to welcome new employees: Shane Emerson, Anthony J. Castaldo, and Robert K. Ripley to our Police Department.

We now have new sidewalks around the Center of Town with more to come.

The town purchased the old Railroad Freight Station. No decision has been made for its use.


In July a tornado came through a section of town (Rte. 16 and the Granite section) causing hundreds of thousands of dollars in damages. Thanks to our Highway Crew, the Police Department, and Fire Departments, and all those who helped in this time of emergency.

At the request of the Town's people, in August the Board of Selectmen held a Public Hearing to discuss the feasibility of merging the three fire precincts. All precincts were present. OSSIPEE MAIN STREET PROGRAM

2008 Annual Report



2008 was a busy year filled with many accomplishments made possible through the collaborative efforts of Ossipee Main Street volunteers and donors. Volunteers working on a wide variety of committees, projects, special events and partnership projects donated more than 3,700 hours of their time (equal to over \$72,000 in donated time) to Main Street this year. Private and public property owners reinvested nearly \$280,000 to complete 11 property improvement projects within the designated target area.

Major projects in 2008 included the Center Ossipee Town Park, park building rehabilitation and renovation, street light conversion, the wayfinding and signage project, a program assessment that resulted in the successful re-accreditation of the program, special events to raise awareness of and funds for Main Street efforts, and the development of a five-year plan at the request of the Ossipee Select Board.

A beautiful park was created in Center Ossipee Village in 2008. Many volunteers spread, graded and raked loam in preparation for hydro-seeding. A dedicated group of volunteers - who have become fondly known as the "Park Angels" - planted perennials, shrubs and bushes, and annuals. After input from a licensed arborist, Red October Maple trees were planted and re-planted with plenty of space for future growth. Other volunteers designed, donated and planted spring bulbs for all to enjoy when the snow finally disappears. One volunteer discovered a unique program offered by the Horticulture Club at the University of New Hampshire's Thompson School. Students enrolled in the irrigation class designed an irrigation system complete with moisture sensors that will shut the system down when the ground does not need additional watering. The students under the supervision of their professor installed the piping and sprinkler heads in November. They will return as soon as the snow is gone and the ground is thawed to connect

the system to the water supply and the timer. All the materials for the park were purchased with funds raised through various Main Street fundraisers over the past two years. Loam, landscaping boulders and perennials were donated. A park grand opening is being planned for May 30.

Much work has also been completed on the building. In the spring, the water and sewer lines were reconnected to the building. A local septic engineer donated his crew for the installation, and a local plumber donated his time to complete the rough plumbing. Many building professionals donated their skills to modify and finalize interior building plans. The building has been reframed, exterior doors and windows installed, electric, internet, DSL and alarm wires run; heating system installed, and the sheet rock hung and primed ready for painting. A local locksmith installed locks. A local painter has offered to donate paint and labor to finish the interior walls. Hopefully, the building will open in March for use, with building tours available during the park grand opening in May.

Partnerships:

Ossipee Main Street partnered with the Town and many local non-profits throughout the year including the Ossipee Highway Safety Committee, the Capital Improvement Committee, the Greater Ossipee Area Chamber of Commerce, the Carroll County Transportation Project, Ossipee Concerned Citizens, Ossipee Historical Society, Ossipee Old Home Week Committee, Ossipee Economic Development Committee, Mount Washington Valley Economic Council, Lakes Region Planning Commission, and the Chef's Pants Off Committee.

Through these partnerships, the Town was awarded a federal Safe Routes to School Grant for \$81,422 to connect the sidewalks with Ossipee Central School on both sides of the road. The streetlight replacement initiative for efficient lighting required collaboration with all three fire precincts and is projected to save 39% on future streetlight electric bills. Through collaboration with the Ossipee Historical Society and the Greater Ossipee Area Chamber of Commerce, a summer calendar was developed to help identify all the summer events and happenings in the area. The goal of the calendar was to promote the event as well as reduce schedule conflicts to help events be more successful. In late summer, Ossipee Main Street successfully applied to the New Hampshire Charitable Foundation for a capacity building grant to help Ossipee Main Street, The Ossipee Historical Society, Ossipee Concerned Citizens and the Greater Ossipee Chamber of Commerce strengthen their organizations through board and staff training and strategic planning as well as identifying areas of future collaboration and opportunities to share resources to reduce costs.

In January 2008, Ossipee Main Street once again helped with the Chefs' Pants Off. Funds from the event were used to bring the Vietnam Veterans Memorial Wall to Center Ossipee over Memorial Day Weekend. In February, the youth fishing derby was named to honor Joe Skehan, Ossipee Selectman. Joe, a long time supporter of youth activities, was instrumental in making the derby headquarters possible. In March, the Economic Fair returned to Town Hall with more workshops. Sadly, the Ossipee Valley Rotary Club made the decision to disband. In doing so, the Rotary donated funds to the Ossipee Main Street program to help with the work in the park. The Community Development Finance Authority (CDFA) gave Ossipee

Main Street a grant to help improve the signage used in town, making it more attractive and less confusing to people new to town. The plan will be presented to the selectmen in March 2009 with a goal of beginning to install signs in 2010. The Rubber Ducky race was held once again, along with an inaugural Beech River Run 5k Road race and youth fun run, with more than 40 people participating in the race. As fall approached, volunteers from Ossipee Main Street and the Ossipee Garden Club once again prepared holiday sprays to decorate the target area properties. They also participated in OCC's Holiday Fair.

Things to watch for in 2009 include:

- *A Farmer's Market
- *The establishment of a working group to save the Chamberlain Block Grain elevator rumored to be the only one of its type this side of the Mississippi River.
- *The park's grand opening
- *Gazebo design and fundraising plans to build it
- *The return of the BBQ in the park

Throughout this past year, the enthusiasm and support for the efforts of the Ossipee Main Street grew considerably. Every event or project elicited new volunteers who came forward and offered to help with a specific project or volunteer a special talent or skill. We'd like to take this opportunity to thank them as well as the Town of Ossipee and each of our supporters for all our success. Without all of you, our work would not be possible. 
Since my appointment as chief I have been working with the Recreation Department to sponsor Friday evening dances once per month for the middle school youth.

Activities Report, 2008

To the People of Ossipee:

In 2008 Medstar responded to nearly 1900 calls completing yet another busy year. In addition to our emergency work we have made many updates and improvements to the services we provide.

Our staff now includes 33 NREMTs, certified from basic level to paramedic. We operate with 6 crew members on duty 24/7. We are proud to say we have paramedic level service a minimum of 76 hours per week. Though it is not required we believe it is of extreme importance. We now have five ambulances, and within the next couple of months, that will increase to seven. In an effort to offer the people of our area more comprehensive service we soon will be offering wheelchair van transportation. In the spring we will be placing a small motor home in service. This vehicle will be used to provide rehab for firefighters, a command post for extended rescues, and a mobile first aid room for events. Again, this is not a requirement, but it is an added service that we believe has considerable importance. Through our Operations Manager, who is a NH certified EMS Instructor we are now offering EMT Basic as well as EMT Intermediate training locally. We now have a full-time certified mechanic in house. This has made a tremendous difference in our maintenance program and ensures a faster turn around on vehicle repairs. Ambulances are no different than our own vehicles. When they develop a mechanical issue it is important to get them back in service as soon as possible. An in house mechanic has proven to be of great benefit.

We look forward to our continued growth and improvement and in our service to The Town of Ossipee.

I would like to Thank the Board of Selectmen, West Ossipee Fire & Rescue, Center Ossipee Fire & Rescue, Ossipee Corner Fire & Rescue, The Ossipee Police Department, The Highway Department and of course the people of Ossipee for their continued support.

OSSIPEE HISTORICAL SOCIETY

Annual Report - 2008

In 2008, the Historical Society focused on raising funds to preserve and maintain the historic Court House we have owned since March, 2005. Extensive repairs were completed on the slate roof and flashing. A security system that monitors against fire, freezing temps, and unauthorized entry was installed. Repairs were made to damaged ceilings and walls. A group of volunteers installed rigid insulation panels over the courtroom windows to reduce heat loss.

In March the Historical Society benefited from a Native American Concert featuring six musicians using traditional instruments. A Bluegrass band also performed, as well as a guitarist who played and sang inspirational hymns. In May we hosted the annual meeting of the Pequawket League, representing area historical societies. In September we hosted the Ossipee Main Street program's public meeting to develop a Wayfinding/Sign Plan for the town. Throughout the summer, we displayed an exhibit of lake-themed photos taken by a local artist.

Our programs featured a report by Adam Spencer on Ranger Companies of Early New England in April, and in May Richard Gale talked about the History of Tennis. In June we held a birthday party for the Historical Society featuring music by Seth Austen and Beverly Woods. Attorney Warren Lindsey gave a riveting account of the Ralph Jennings murder trial at our July meeting, and in August Frank Bodurtha recounted the Hurricane of 1938. Our September program featured Jody Skelton and Gene Clark, who told the story of YMCA camps Huckins and Belknap, which tied in with our ongoing exhibit of Carroll County summer camp memorabilia. In late September we sang "One Last Song around the Camp Fire" to celebrate the end of summer, and to enjoy one last look at our featured exhibit. The annual service at the Early Settlers Meeting House was held Sunday, August 17th.

The candidates for State Representative in District 1 debated at the Court House, and on another evening the contenders for the NH Senate faced a full house of interested voters. A candidates' forum night featured those running for County Commissioner, Register of Probate, and State Representative. All these events were hosted (but not sponsored) by the Historical Society.

In 2009 we must focus our attention on much needed repairs to both Grant Hall and the Early Settlers Meeting House. These buildings are an integral part of Ossipee's history, and our mission as the guardians of the past demands that we ensure they endure to be appreciated by the next generation. We offer sincere thanks to the people of Ossipee for their support, and invite all those who are interested in preserving history join us in our efforts.

OSSIPEE PLANNING BOARD

2008 Annual Report

The Ossipee Planning Board meets on the first and third Tuesdays of each month at 7 PM at the Ossipee Town Hall. Additional work sessions are held on the fourth Tuesday of the month as needed to work on changes to the Ossipee Zoning Ordinance and other Planning Board business. Bruce Parsons was re-elected Chairman, Bill Grover Vice Chairman, and other members are Ralph Buchanan, Karen Foster, Donna Sargent, and Bob Gillette. Carol Gartland is the Selectmen's Representative, and Roger ter Kuile is an Alternate. David Senecal, Zoning Enforcement Officer, attends the meetings also.

In 2008 the Planning Board approved 4 Subdivisions for a total of 12 lots, 10 Site Plan Reviews, 4 Mergers of Lots, 1 Boundary Line Adjustment, and 2 Special Use Permits.

Two Excavation Permits were renewed for two years. A lot of time was devoted to updating the Ossipee Earth Excavation and Reclamation Regulations based on RSA 155E. They were adopted on August 19, 2008 following a public hearing. Now Excavation permits can be issued for up to 6 years.

The Ossipee Planning Board recommends that applicants meet with Dave Senecal, our Zoning Enforcement Officer, before applying to the Planning Board to help ensure compliance with all zoning issues. The Planning Board encourages a pre-application discussion with the board that can be scheduled for any Planning Board meeting following the noticed hearings. Each Site Plan Review Application includes a checklist for Minor or Major applications determined by the applicant based on the size of the project. If the checklist is incomplete, the application is not acceptable.

We welcome and encourage any interested people to attend our meetings, as input from the townspeople helps determine the direction of the Planning Board. We are looking for people to serve as alternates. It is a good way to learn about the work of the Planning Board in your town and make your voice heard in the community.

The Planning Board has spent many hours increasing consistency by recommending some changes in the Zoning Ordinance. Most are of a housekeeping nature. Specifically, one change allows the ZBA more latitude in scheduling hearings and another reduces the size of lots for Cluster Housing.

Planning Board member, Bob Gillette, was instrumental in developing a lighting ordinance that encourages downcast lighting to retain our Dark Skies. He is also Chairman of the Capital Improvement Committee formed to compile major projects identified as important for the next few years by department heads, committees, and other sectors of town government. Lakes Region Planning Commission has worked with the Planning Board on developing a Capital Improvement Plan.

OSSIPEE ZONING BOARD OF ADJUSTMENT ANNUAL REPORT 2008

Members of the Board are Jean Simpson, Chairman; David Babson, Vice Chairman; Jonathan Brown, Ann Johnson, and Bruce Parsons. Alternates are Lisa Hinckley, Stanley Brothers, and Mark McConkey.

Ten Public hearings were held in 2008. At these meetings, fifteen cases were heard. Many of these applications were from property owners wanting to make changes in homes that do not meet the setbacks from the property lines according to the present Zoning Ordinance. Several requests to extend or renew the time limit of one year on Variances were considered. The Zoning Board has adopted a policy of not extending the Variance, if the one year time limit has expired, so the applicant must reapply. One Special Exception was granted, and one Appeal of an Administrative Decision was denied.

If the applicant is denied a building permit because of the need for a Variance or a Special Exception, Dave Senecal, the Zoning Enforcement Officer, issues a denial and instructs the applicant to apply to the Ossipee Zoning Board. The Zoning Enforcement Officer attends most of the Zoning Board meetings. He makes sure that all the conditions placed on a decision by the ZBA are satisfied, before he grants a building permit. Several cases were referred to the ZEO for his inspection and follow-up. The Zoning Board of Adjustment has worked closely with the Zoning Enforcement Officer to ensure that possible violations of the conditions of a decision are reviewed.

Applicants would hasten the process by being sure they have included all the information requested in the application packet. The ZBA adopted a checklist for the applicant that must be completed before submitting the application, and signed by the ZEO or the secretary indicating that it is complete.

LAKES REGION PLANNING COMMISSION

The Lakes Region continues to grow and evolve. Homes and businesses have expanded along major roadways, and many of our communities have experienced dramatic changes. The Lakes Region Planning Commission (LRPC) is an organization established to provide area communities and region with the capability to respond to and shape the pressures of change in a purposeful way. With a service area covering over 1,200 square miles in Belknap, Carroll, Grafton and Merrimack Counties, the LRPC provides a wide range of planning services to member municipalities. The Commission offers direct and support services including technical assistance, geographic information systems, transportation planning, land use, environmental planning, hazard planning and economic development. Local, state, and federal resources primarily fund the LRPC. We also maintain a regular dialogue with state agencies as a resource for the entire Lakes Region. Our overall goal is to provide support, knowledge, and leadership to the governments, businesses, and citizens of the Lakes Region.

Below are some of the focus areas and services provided on behalf of the town of Ossipee and the region in the past fiscal year:

LOCAL

- Collected and processed many traffic counts, including a directional count requested by local officials.
- Provided circuit rider planner assistance to the town
- Assisted local officials with the town's Safe Routes to Schools application.
- Attended the Plan NH Charrette in Center Ossipee. Met with members of the Planning Board to discuss possible changes to the Ossipee zoning ordinance. Developed and printed aerial photo and tax maps for the charrette.
- Initiated the start-up of the town's new Capital Improvement Program (CIP).
- Provided information to the NH Fish & Game regarding the proposed boat launch at Conner Pond in Ossipee.
- Updated the town's zoning map, in consultation with local officials.
- Distributed many copies of the NH Planning and Land Use Regulation books to member planning boards at considerable savings.
- Organized and hosted three public Municipal Law Lectures, in cooperation with the NH Local Government Center, where practicing attorneys provide a legal perspective on local planning, zoning, and other municipal issues.

LAND USE

- Responded daily to requests from local communities for land use, transportation, environmental, and other information and guidance.
- Prepared master plans, capital improvement programs, zoning ordinances, subdivision regulations, and related services for several communities.
- Maintained circuit rider planning services for municipalities interested in assistance with development proposals.
- Developed a website of electronic documents to facilitate the outreach/education component of the Innovative Land Use Guide project, completed by the nine regional planning commissions and the NH Department of Environmental Services.

TRANSPORTATION

- Developed an update of the top regional transportation priorities, in cooperation with area communities, and submitted them to the NHDOT for review and consideration.
- Convened several meetings of the LRPC Transportation Advisory Committee (TAC)

to enhance local involvement in transportation planning and project development.

- Conducted over 160 traffic counts around the region and prepared and updated several local road inventories, on a town-by-town basis, that will be used by the DOT and the municipalities.

- Presented testimony to the Governor's Advisory Commission on Intermodal Transportation to retain all Lakes Region projects in the state's Ten Year Plan.

HOUSING

- Completed and distributed the 2008 Development Activity in the Lakes Region report on Lakes Region residential and commercial development trends. Prepared and distributed a new development survey for 2008-2009.

- Staff became qualified by the NH Housing Finance Authority to help communities implement the new Workforce Housing Law.

ECONOMIC DEVELOPMENT

- Awarded \$50,000 from the U.S. Economic Development Administration to prepare a Comprehensive Economic Development Strategy (CEDS) for the Lakes Region. An approved CEDS will provide communities with access to EDA funding for infrastructure and economic development projects.

- Continue to work with area economic development groups including Belknap County Economic Development Council, Grafton County Economic Development Council, Franklin Business and Industrial Development Corporation, and the Wentworth Economic Development Council.

NATURAL RESOURCES

- Planned and coordinated the 22nd annual household hazardous waste collection in the Lakes Region with 1,500 households from 23 communities participating at 8 collection sites. An estimated 19,000 total gallons of waste were collected, containerized, and transported to EPA approved end-of-life locations.

- Continue to provide assistance to the Pemigewasset Local River Advisory Committee.

- Participated in a number of meetings related to: source water protection, proper disposal of pharmaceuticals and personal care products, low impact development benefits to ground water, and how to implement ground water protection ordinances with municipalities.

- Continue to represent the region at meetings of the Lakes Region Household Hazardous Product Facility to explore the ways and means the facility may encourage other communities to participate.

- Created a series of web pages to provide an overview of various energy topics including: solar, geothermal, biomass, wind, and hydro-power.

- Hosted a training session for Volunteer River Assessment Program (VRAP) water quality monitors.

- Received funding assistance from the NH Department of Environmental Services to conduct the first phase of the Lake Winnepesaukee Watershed Management Plan. Project partners include Lake Winnepesaukee Watershed Association, the University of New Hampshire, Plymouth State University, and the North Country Resource Conservation and Development Area Council.

NATURAL HAZARDS

- Secured funding from the NH Department of Homeland Security and Emergency Management (HSEM) to prepare all hazard management plans for Lakes Region communities.

- Attended training to prepare local emergency operation plans (LEOP).

REGIONAL CONCERNS

- Completed an overhaul of the LRPC website, www.lakesrpc.org, added many new features to facilitate access to on-line images for each municipality, recent publications, latest news, etc.
- Convened six Commission meetings that featured a diverse range of topics: NH Rail Transit Authority, the Downeaster, NH Rail Service, and Next Steps; Viewshed Management and Steep Slope Protection in the Lakes Region; Incentives for Housing, Smart Growth, and Conservation; Transportation Plans/Projects; Comprehensive Shoreland Protection Act: Its Future and Current Status.
- Reviewed project proposals through the NH Intergovernmental Review Agreement having a combined investment total greater than \$55 million in the Lakes Region.

MT. WASHINGTON VALLEY ECONOMIC COUNCIL

2008 Town of Ossipee Report

The goals of the Mt. Washington Valley Economic Council are to encourage economic diversity and help area businesses succeed and grow. In difficult economic times our local dependence on a recreation and retail economy draws attention to the need for a variety of other jobs, hence the creation of the Tech Village and the adjoining Learning Center to help local businesses prosper. In the past five years alone, the Tech Village incubator for start-up businesses has created 43 new jobs, which in turn help the overall economy of the region.

In its recent communication to members, the MWV Economic Council listed some of the ways that membership helps local businesses:

- If you're looking to expand your business, you may be finding that getting financing is tough. The Council's **Revolving Loan Fund** provides gap financing for business endeavors that otherwise might be unable to secure financing. To date the Council has made 43 loans to local businesses totaling nearly \$2.8 million.

- Get the quality **technology education and business skills training** you need to stay ahead. The Learning Center at the Tech Village is home to Granite State College, White Mountains Community College and Plymouth State University classes.

- Receive **free and confidential business guidance and advice** from seasoned experts who are part of SCORE (Service Corps of Retired Executives). SCORE is also located at the Tech Village.

- You'll also have access to **ongoing educational and informational forums**. There are also discounts available on entry fees to Council events, newsletters and other activities.

The Council is funded through a combination of grants, membership dues, interest generated by the Revolving Loan Fund and corporate sponsorships which underwrite many of the educational programs and events. Participation of individuals and Towns like Ossipee help ensure that MWV Economic Council continues to meet the needs of and be a voice for local businesses.

OSSIPEE CONSERVATION COMMISSION

Annual Report for 2008

The Ossipee Conservation Commission meets the second Wednesday of the month at 7 PM in the Ossipee Town Hall. The public is encouraged to attend. Commissioners are appointed by the Selectmen to assure protection and proper utilization of Ossipee's natural resources under RSA 36-A. Re-elected as Chair and Vice Chair were Elizabeth Gillette and Warren Walker, respectively. Other Commissioners are Ralph Buchanan, Andy Northrop, Jean Hansen, Kevin Houle and Bob Pratt.

Several notable events impacted natural resources in Ossipee in 2008: A disastrous tornado on July 24 toppled hundreds of healthy trees as it carved a swath from west to east across the southern portion of town; the NH Comprehensive Shoreland Protection Act governs as of July 1 most alterations within 250 feet of shoreline; a working group was organized by the NH Department of Recreation and Economic Development to review management impacts on the Ossipee Lake Natural Area; and 20+ acres of land on Route 16 were purchased for town conservation and open space.

In early spring the Commission succeeded in purchasing the "Window on the Ossipee Mountains" property to permanently protect the 20+ acre site located on the west side of Route 16 south of Boulder Farm. The purchase capped a 15-month fundraising drive in which the Commission raised \$250,000 to buy the site that is abutted by conservation land. No funds raised from taxation were used for the purchase. The Ossipee-based land trust, The Dan Hole Pond Watershed Trust, acquired a conservation easement on the property at the time of purchase that assures the land will remain open space in perpetuity. The Commission will manage the site for the town to conserve the magnificent view of Mt. Shaw and neighboring peaks; to maintain valuable early successional wildlife habitat; and to protect the underlying aquifer. The Commission plans to create a scenic overlook on the property in 2009 and a nature trail in 2010.

The Commissioners are grateful to all who helped the "Windows" project succeed. Funds to buy the property included over \$120,000 in individual donations plus over \$60,000 in Conservation Commission funds, over \$18,000 from The Dan Hole Pond Watershed Trust, a \$15,000 New Hampshire Charitable Foundation grant, an \$8,000 grant from The Little Family Foundation, an \$8,000 grant from the Fields Pond Foundation, and over \$18,000 donated by the local business community including \$10,000 from Realty Executives Lakes Region Office and \$5,000 from Pike Industries. A \$1,500 grant from the New England Grassroots Environment Fund (received in 2007) enabled brochure printing and fundraising solicitations. The Commission especially wishes to acknowledge and to thank Town Treasurer Natalie Hall for handling project donations; Town Clerk Kellie Skehan for guidance on required public hearings; and Conservation Commission Secretary Pat Jones without whose tireless work success of the "Windows" project would have been unlikely.

By July the “Windows” property had been cleared of debris that remained from businesses formerly located near the roadside, thanks to volunteers who rolled up their sleeves for several clean-up sessions. In late summer, a baseline natural resources inventory, funded by the Commission and The Dan Hole Pond Watershed Trust, confirmed that the site is important early successional habitat for wildlife. In his inventory, wildlife biologist Dr. Rick van de Poll noted, “A total of 294 vascular plants, 195 fungi, 14 mammals, 14 birds, 1 reptile, 4 amphibians and 88 invertebrates were identified on the Windows property.” This reflects significant natural regeneration in spite of the heavily disturbed surface soils that date from business activities of the eighties.

A topographic survey of the “Windows” roadside area was completed in the fall. The Commission is very grateful to Land Tech for donating this \$3,595 survey to enable plans to be drawn up for the scenic overlook. The Commission is also grateful to B. H. Keith Associates for donation in December of a \$1,225 forest management plan for the “Windows” property that prescribes minimal clearing to maintain the scenic view and important wildlife habitat.

The Commission was actively engaged in work beyond the “Windows” project to protect Ossipee natural resources. The Commission partnered with the Green Mountain Conservation Group to sample water at 14 sites on rivers, lakes and streams. Volunteers are always needed to do biweekly sampling from April to October. The Commission also supported for the third year the Lake Host Program (under the NH Lakes Association) to check boats entering and leaving Ossipee Lake for milfoil and other invasive species whose presence could ultimately hamper communities like ours that draw support from waterbased tourism. Commissioners Jean Hansen and Warren Walker oversaw Lake Host Point Person Nick Paquette and two assistants at Pequawket Trail landing from May 29 to September 1. The NH Lakes Association credits Lake Host for mitigating the spread of invasive species among NH waters.

The Commission organized two gatherings for information and education. We co-hosted with the Green Mountain Conservation Group an Open Space/Conservation Easement Workshop on April 29 at the Ossipee Library which 30 people attended to hear four featured experts on land protection techniques. On August 21 at the Ossipee Town Hall we co-hosted with the Freedom Conservation Commission and the Green Mountain Conservation Group a presentation by Sara Sumner of the NH Department of Environmental Services on “Ossipee Lake Monitoring Results.” The Commission also co-sponsored with the Ossipee Lake Alliance and the Freedom Conservation Commission a workshop on June 21 at Camp Calumet on “Landscaping at the Water’s Edge: An Ecological Approach.”

Blazing and painting of boundary lines was completed on the Sumner Brook conservation land at the fish hatchery on both sides of Route 16. Commissioners accompanied Ken Stern, Director of Easement Stewardship at the Society for the Protection of New Hampshire Forests, on a site visit to monitor the parcel east of Route 16 (on which the Society holds an easement) and found it in excellent condition with healthy new growth evident as a result of the timber harvest in 2007.

The Commission reviewed 40 communications to and from the Department of Environmental Services, such as individual applications to work in the shoreland protection zone or wetlands or other area that would require a DES permit or monitoring. The Commission also noted 33 "Intents to Cut" forwarded by the Selectmen. At least 13 of these were for tornado-damaged lots. The Commission made 2 site visits to review possible impact on Ossipee natural resources of proposals to subdivide and to develop land. Commissioners attended six meetings, hearings or training sessions to become more knowledgeable on issues affecting their responsibilities. These included the annual meetings of the NH Association of Conservation Commissions and the NH Lakes Association, Saving Special Places, and a public hearing on NH Guidelines for Coordinating Lake Management & Shoreland Protection Plans.

Finally, the Ossipee Conservation Commission was presented the Lakes Region Planning Commission Award of Excellence on June 23, 2008, for "outstanding community conservation efforts, leading to the permanent protection of the "Windows on the Ossipee Mountains" - a site prized for its magnificent views and natural resources on NH Route 16."

We have launched 2 of our own initiatives this year.

One is called **GET O.U.T.!** Our goal is to encourage all of you to simply GET OUT and participate in an activity. O.U.T. means: get **Outside**, Use your mind and resources, and Try something new.

The 2nd is the **Just Say "NO!"** Day. What we want you to do is to pick a day and say "no" to work, cell phones, pagers, computers, t.v., video games, and any other responsibilities you have and take the day for yourself and/or your family.

We also partnered with the Foundation for Healthy Communities and the Upper Valley Trails Alliance to offer the Passport to Winter Fun for children. The "Passport" is designed to encourage children to get active outdoors in the winter. Children can record their activities, up to an hour a day, their activity and in return can obtain prizes for reaching milestones of 10, 20, and 30 consecutive days of outdoor activity. Over 140 children and their families participated. This was funded by the Foundation for Healthy Communities.

Our goal for the Department remains to: "Offer a wide range of activities for all ages designed to meet the needs of the community, and to encourage healthy use of your leisure and recreation time." It does not matter what your age, there is always something for you to do. If you have an idea for a new program or activity, please call us at 539-1307 and we can discuss your idea and possibly include it into our schedule of programs and events. Many of the programs and events you see listed here are the result of a conversation that we have had with someone who had an idea for a new program. We are working hard to provide the best continuing and new programs we can for this community.

We received grant-funds for 2 programs in 2008:

The 1st is the **"Summer Programs at Ossipee Recreation for Teens (S.P.O.R.T.)."** This grant of \$5000.00 was awarded through the Carroll County Prevention Program Development Funds. This program provided a 6-week summer program for ages 12-16. We had 24 youth registered for this great Program.

They completed community service, ran games and activities for the younger kids camp, went to water and amusement parks, canoe trips, and had a

blast. We have applied for, and received, this grant again in the amount of \$6000.00 for the summer of 2009. As a result, Assistant Director, Jason Hanken, a group of teens assists him in planning this and additional activities for teens. For more information on this, (and other activities), please contact Jason.

The 2nd was a **Field Hockey Equipment Grant** from the US Field Hockey Association Equipment Grant Program. We received one dozen sticks, balls, shin guards, and mouth guards for the youth field hockey program. The Equipment has an approximate value of over \$2500.

A small group of people including members of the Ossipee Main Street Program, myself, Brad Harriman and members of the public have been meeting to discuss the feasibility of a SkatePark in town. The SkatePark Committee has conducted some fundraising this year raising just over \$3000 towards the project. A survey was distributed and had a great response from youth and adults. The Committee plans to renovate the existing Ice Skating Rink into a multi-seasonal facility. It would be a Skatepark in the spring, summer and fall and remain an Ice Skating Rink in the winter. We have 2 Warrant Articles this year. One is asking for \$8000 to place a permanent surface in the Ice Skating Rink. The other is to create a line item to accept grant money, should we receive the grant, from the Tony Hawk Foundation for equipment. The maximum amount we could receive from the grant would be \$25,000.

We continue to search for alternative funding for programs and activities.

The Town is responsible for the following Recreation Areas and Facilities: Swimming Area: Cleveland Beach (Town Beach on Duncan Lake), Boat Landing's: on Pequawket Trail, on Harpers Ferry Landing, on Ossipee Lake Drive, Nichols Road, Whittier Bridge Area, and White Pond, Parks. Ballfields. Hiking Trails & Tennis Courts: Constitution Park, Ballfields & Basketball Court: YMCA Field, Park: Mill Pond, Equip Recreation Area (on Newman Drew Road), Other: Outdoor Ice Rink, Indoor Facilities: Town Hall Gym.

The development and maintenance of Town recreation facilities is jointly monitored by myself, Dave Senecal (Zoning Enforcement Officer), and Brad Harriman (Public Works Director), and the Board of Selectmen.

This past year work on the maintenance and development of the Town's Recreation Facilities continued with the following projects that were completed in 2008:

- Water repellent application to the elevated walkway on the trails at Constitution Park (Spring & Fall),
- Organic fertilization of the fields at Constitution Park and the YMCA Field,
- Water repellent application to the decking at the Mill Pond,
- Installation of sand and picnic tables at Duncan Lake in the new picnic area,
- Resurfacing and crack repair on the Tennis Courts at Constitution Park,
- Application of pest controls at Constitution Park and the YMCA Field to address issues with grubs and cinch bugs,
- New carpet in the Recreation Department Office,
- Renovation of the Recreation Department Office for an office area for the Assistant Director,

- Ice Rink repairs,
- Annual Clean up of Constitution Park in the spring.

What we would like to accomplish, or begin, in 2009 are:

YMCA Field:

- New scoreboard,
- Installation of water,
- Continued monitoring and treatment of bug infestation in the turf,
- Resurfacing of the infield dirt on the large diamond,
- Resurfacing and crack repair on the basketball court.

Constitution Park:

- Explore additional water sources for irrigation,
- Annual Trail Clean up and maintenance,
- New Scoreboard,
- Continue work on the new baseball/multipurpose fields,
- New tennis nets and a wind screen on the courts,
- Renovate the outfield of the existing baseball field,
- Continued monitoring and treatment of bug infestation in the turf on the fields.

Town Beach at Duncan Lake:

- Install new swimming markers,
- Paint the Lifeguard tower.

Bear Camp River Site:

- General Clean up of site,
- Make the access road passable for vehicles,
- Investigate possible non-motorized/hiking trail development,
- Begin to renovate the Amphitheatre on site there.

General:

- Investigate ways improve security in all park facilities,
- Improvements to the Mill Pond Park Area,
- Picnic tables for all areas,
- Ice Rink repairs.

Some of the goals we have for the next 3-5 years include:

- Installation of a Roof over the Ice Skating Rink,
- Installation of a permanent surface in the Ice Skating Rink,
- Skatepark,
- Community/Teen Center,
- Playground equipment at all facilities,
- Additional programs for all (especially adults, teens, and families).

Our parks, trails, and ball field's are used for a wide variety of events and activities during the year. Weekly updates in the local newspapers and occasional announcements on Channel 3 on Cable TV are sent out to keep you up-to-date on what is happening with the department. In addition, the Program Brochure is published on a quarterly basis (Spring: March - May, Summer: June - August, Fall: September - November, and Winter: December - February) that serves as a handy resource for you to inquire about what is available through the department. 1300 - 1800 are produced each Quarter. The size and content of the brochure continues to expand as more programs and activities are added. We continue to participate in the NRPA (National Parks & Recreation Association) Program Brochure Exchange Program. Ossipee's brochure is sent out to recreation departments around the Country. In return, they send their brochures to us. It is a wonderful way to network and share ideas.

The department is also actively involved in the organization of the Ossipee Old Home Week, the Ossipee Central School's "School's Out" After-School Program, The Ossipee Main Street Program, Carroll County Collaborative, and other local activities and events.

I currently serve on the Social, Awards, and Program Committees for New Hampshire Recreation & Parks Association (NHRPA). I am also a member of: Ossipee Old Home Week Committee, Ossipee Central School "School's Out" Advisory Board, and the Carroll County Collaborative Advisory Board, and I am an Instructor for the American Red Cross. Jason is also a member of NRPA, NHRPA, and the "School's Out" Advisory Board. He is also a certified instructor for the Coach Smart NH youth coach's curriculum. He is also the Web Site Coordinator for the New Hampshire Recreation and Park Association (NHRPA). We both are members of the Planning Team for the Northern New England Park & Recreation Conference. Annual Report for the year 2008

New Hampshire residents are naturally independent based on the need to be innovative and multi-talented, especially during the winter months north of Portsmouth. Here in Carroll County much of our employment is seasonal. Snowstorms help the economy. Tourists have the lakes and mountains to enjoy. But gas prices affect travel. And it is more important to heat your homes than ride the slopes. The recession has taken its toll, and will continue to do so for some time. But discipline and creativity are always available.

Ossipee Crossing has taken an energy-savings position on battling the difficult economy. In particular, more attention is given to thermostat adjustment, and turning off lights and equipment at the proper time. OCC staff has asked Public Service Company of NH to perform a free energy analysis of the building to improve energy efficiency (which may include additional insulation). Further, six upstairs windows were replaced with new energy-saving vinyl windows (a noticeable improvement).

A little over a year ago, a new laminate floor was installed in the dining area, which replaced an aging carpet. More recently, the original "cook shack" adjacent to the main building was replaced with a more functional structure. This could only have been accomplished by the generosity of several groups and individuals who donated time and/or materials to the project. The building is now housing the winter coat project, and will in the near future be utilized as a new "cookshack" and storage area with a different name- the OCC Annex.

The Elderly Nutrition Program has increased coverage to include meals-on-wheels to Wakefield. The program continues to provide meals-on-wheels and congregate meals from two main sites at Ossipee Crossings (Ossipee, Effingham, Freedom, and Tamworth), and at the Moultonboro Lions Club (Moultonboro and Sandwich). In addition, there are two satellite sites for congregate meals in Tamworth and Sandwich. Between the years 2006 and 2008, the total number of meals served at all sites increased from 72,000 meals to 80,715. The total program remains under the auspices of Ossipee Concerned Citizens, Inc.

The OCC Carroll County WIC (Women, Infants, and Children Nutrition/Education) Program has a central office at Ossipee Crossings. The program provides nutrition and breastfeeding education and counseling, and food vouchers to eligible clients within Carroll County. Certification and voucher clinics are held at seven different sites within that area. As a part of the program, the Commodity Supplemental Food Program (CSFP) is available to eligible Wic participants, and seniors 60 years and older. Boxes of non-perishable foods and cheese are distributed at two clinic sites (Ossipee and Conway) on alternating months, or at OCC at specified times. For those unable to pick up the boxes, members of the WIC staff make deliveries to client residences. Farmer's Market vouchers are also available during fresh produce season.

OCC is proud of the Ossipee Crossing Child Care Center which opened in 1994. A very experienced staff coordinates a variety of fun learning experiences during each weekday from 6:30am to 5:30pm for children three to twelve years of age. The day care center offers licensed pre-school for three and four year old boys

and girls who spend a period of time each day with a basic curriculum in Early Childhood Education. Subsidized funding is available to eligible families.

Under the sponsorship of Ossipee Concerned Citizens, Inc. is the Ossipee Senior Center. Certified by the New Hampshire Association of Senior Centers, the center was developed originally through connections with the nutrition program. Activities to promote physical and emotion wellness have been scheduled based on the benefits of participation and socialization. The number of programs with a direct health benefit have also been expanded. The following is a list of those programs exclusive to OCC or in conjunction with other organizations and individuals: T.O.P.S, Clinics on Diabetes Education with Wolfeboro VNA, Nutrition For Health with OCC WIC, monthly Blood-pressure Clinics with Wolfeboro VNA, monthly Footcare Clinics with Lakes Region General Hospital, monthly Hearing Testing with Dr. Ed Burns, Annual Flu Shots with Wolfeboro VNA (open to public), Senior Game Day with Ossipee Recreation Department, Monday Night Whist at OCC, Monday Afternoon Bingo at OCC, shopping trips, birdwatching, social event trips (Portland Flower Show, Duck Boat Tour in Portland with ORD), and a variety of additional day trips across Maine and New Hampshire.

In addition to the above events specific to the senior center are the following activities which combine fundraising and entertainment: OCC Uptown Boutique, Fourth of July Celebration with VFW Post #8270 and Ladies Auxiliary, Annual Spring Fling, Annual Harvest Fair, penny, rummage, and yard sales, public turkey suppers, and limited catering.

OCC is a not-for-profit multi-purpose human services agency whose annual budget is \$845,000.00. Contracts with a variety of funding sources enable OCC to provide the services identified above. Those sources include the following: Bureau of Elderly and Adult Services (Department of Health and Human Services), the United States Department of Agriculture, the Division of Public Health Services and Child Care Development Fund, Lakes Region United Way of Laconia, Ossipee Children's Fund, and town support. Donations and fundraising complete the budget receivables.

Despite the difficult economy during the holiday season, the OCC Santa Project assisted one-hundred fifty-eight (158) families with four-hundred twenty-eight (428) children in Ossipee, Effingham, and Freedom (up slightly from 2007). Over the years the support has never faltered. Groups and individuals in the surrounding area respond together, from donors to sponsors to volunteers, to make the holiday program a success.

It is with a sense of pride that OCC submits this annual report to the citizens of the Town of Ossipee. The Board of Directors and staff are committed to providing quality programming to the benefit of its clients. In addition, and throughout the year, volunteers unselfishly dedicate their time to that same conclusion. With the continued support of the board of selectmen, town office staff, the highway department, department heads and staff, and the residents of the Town of Ossipee, OCC will focus on the future with hard work, and optimism that the year 2009 will be as successful.

Annual Report 2008

This year we served a total of 185 cases at a cost of \$17,448.32. \$11,905.90 of which was liened to the property owner. I found 4 old liens that were uncollectible. One lien (\$277.30) was discharged on repayment to the Town. One lien (\$943.38) was lost due to foreclosure and the law clearly states that it is not collectable. There is one lien in the process of repayment.

There were 5 cases of fraud. These were discovered through due diligence of the application. It is necessary to check all expenses and income claimed or unclaimed and their validity.

The Town has a strict set of Guidelines prepared in conjunction with the New Hampshire Local Government Center. The Town has adopted these guidelines. There is no set amount for assistance but one must fall within the guidelines to be eligible. These guidelines are followed in all cases, as they are legal and binding.

Due to the current economic climate, we are seeing a different clientele.

These are difficult times and decisions on what to pay are not always easy. It has become necessary to pare down the extras and concentrate on family needs.

OSSIPEE WATER AND SEWER COMMISSION

The Ossipee Water and Sewer Commission has continued to make upgrades to both the water and sewer system in Center Ossipee.

“Camp David”

Installation of new control valves on the splitter box, and reconstruction of 2 leach beds was completed this year along with increased hours of operation. The facility received approximately 500,000 gallons of septage and processed more than 32 million gallons of wastewater. Monitoring wells showed all groundwater to be within State and EPA limits. Next year the replacement of several more leach beds is planned.

Water System

The Center Ossipee Water system is in very good condition. All our water tests have come back with excellent test ratings speaking highly of the quality of work and maintenance accomplished by our highly trained staff.

The Dore Street project was placed on hold as our new chief operator wanted to evaluate the entire system during the spring and fall flushing cycles. A Capital Improvement Plan is under development.

The color coding of all fire hydrants to indicate flow was accomplished in the spring, along with painting all the hydrants. Other maintenance included opening and cleaning all valve boxes and exercising the main control valves to assure quick access and proper operation. Several service shutoffs were replaced and six breaks were repaired. Other improvements to the system included replacing the roof and painting the Valley Road building as well as insulating it to reduce the heating need during the winter. Also additional equipment was purchased and installed to assure reliability of the pumping and treatment of the water. An inspection and cleaning of the tank on Valley Road is scheduled for the spring.

Sewer System


Work started on the evaluation of the sewer system to determine why flows increase dramatically during storm events. Several manholes have been identified as possible problems. Residents are also reminded that it is illegal to connect gutters, down spouts and sump pumps to the sanitary sewer system. These devices should connect to storm drains or drain away from the structure.

At this point we wish to extend our sincere appreciation to the various Town Departments for their continued help and support throughout the year: Mrs. Martha Eldridge (Town Administrator) for her help in keeping things moving smoothly, Mrs.

Kellie Skehan and her Tax Office Staff Ms. Trish Hodge and Ms. Tracy Cragin for all their hard work collecting revenue for the Department and last but not least, the Town Office Staff, Ms. Natalie Hall (Treasurer), and Ms. Gail Gliesman (payroll clerk).

We especially wish to thank the Public Works/Highway Department without whose help the Ossipee Water and Sewer Department would be hard pressed.

LAKES REGION HOUSEHOLD HAZARDOUS WASTE COLLECTION 2008 ANNUAL REPORT

The 2008 Lakes Region Household Hazardous Waste (HHW) Collections were conducted in a safe and efficient manner on July 26, 2008 and August 2, 2008 at eight different locations. The event was coordinated by the Lakes Region Planning Commission (LRPC). Turnout was the largest in six years with 1,659 households from twenty-three communities participating. The percentage of households that participated ranged from less than 3% in some communities to more than 7% in others; overall 4.3% of Lakes Region households participated in this year's HHW Collection.

Our survey indicates that 36% of this year's participating households had never before contributed to an HHW collection; this is consistent with what we have seen in the past. We are pleased that each year we have more new households willing to make the effort to dispose of their wastes properly.

This year an Unwanted Medications Collection was held at the Gilford site in conjunction with the Lakes Region HHW Collection. It was open to all residents and homeowners in the participating Lakes Region communities. The bulk of the costs associated with this was paid for by the Gilford Police Department and School District with funds from a two-year grant.

Nearly 20,000 gallons of HHW and more than 25,000 feet of fluorescent bulbs were disposed of properly. The estimated cost per Lakes Region household was \$2.19.

The cost to communities for 2009 will remain the same as it was for 2008. The next Household Hazardous Waste Collections will be held July 25, 2009 and August 1, 2009. All residents and property owners in participating communities are encouraged to take this opportunity to safely dispose of your household hazardous products (check with your local coordinator or LRPC for details).

OSSIPEE HIGHWAY DEPARTMENT ANNUAL REPORT FOR 2008

The winter of 2008 proved to be one for the records. From the end of January thru early March we averaged 3 significant storms each week. Many long nights and weekends were spent on the roads and in the garage keeping the trucks maintained by the Highway Department. I would like to thank the Townspeople for seeing our need for extra funds to supply us with the sand and salt that was required.

When spring finally arrived we were able start our road maintenance program with grading, rolling and treating the gravel roads with calcium chloride. The Highway Department also continued replacing approximately 35 old culverts, and cleaning and improving roadside ditches. Roadside mowing was also a high priority on the summer maintenance program.

July 24, 2008, saw Granite get devastated by a tornado. Again, as with the floods of 2007, we saw the community come together to help in the cleanup effort on Granite Road and Effingham Road. Within 24 hours we had access to all of the properties, and within one and a half weeks all of the roadside pick-up was completed.

Due to the high cost of pavement, more time and effort was spent on rebuilding of gravel roads. Construction projects included the continuation of rebuilding Ossipee Mountain Road, Valley Road, rebuilding and paving of Granite Road, Brookwood Road, and Long Sands Road.

CENTER OSSISPEE FIRE & RESCUE DEPARTMENT

In the year 2008, the Center Ossipee Fire & Rescue Department answered 310 emergency calls. The calls were broken down into the following categories:

Actual Fires - 30; Overpressure Rupture - 1; Technical Rescue and Motor Vehicle Accidents - 34; Hazardous Condition Related Calls - 4; Service Calls - 11; Good Intent Calls, Smoke Investigations, Cancelled En Route - 20; Hazardous Material Incidents - 7; False Alarms - 28; Severe Weather Disasters - 13; Forest Fires - 7; Downed Power Lines - 8; and, Emergency Medical Calls - 133.

The 133 emergency medical calls consisted of the following: abdominal pain: - 5; anaphylaxis shock - 2; assault - 2; back pain - 6; cardiac arrest - 2; chest pain - 7; choking - 1; diabetic symptoms - 2; respiratory distress -15; dizzy spell - 3; head injuries - 3; general sickness -11; lacerations - 1; lift assists - 14; medical alarm activation - 1; miscellaneous traumas - 6; general person down call - 7; seizures - 4; strokes - 4; unknown medical type call - 7; nosebleeds - 4; difficulty breathing emergencies - 16; overdoses - 3; stroke/CVA - 4; unknown medical calls - 10; and, faintings - 7.

During 2008, The Fire & Rescue Department spent 6,945 hours attending firefighter training, medical training and answering emergency calls. The Fire Department Inspection Division spent 3,250 hours completing the following inspections during 2008: oil burner inspections -13; assembly inspections - 66; plan reviews - 8; foster care inspections - 6; new home occupancy inspections - 6.

The Fire Chiefs and duty crew spent 2,400 hours completing Fire Prevention programs, department administration, grant program management, fire department business meetings and trainings, emergency calls, Ossipee Valley Mutual Aid and Emergency Medical Service meetings, department work details, emergency vehicle maintenance and repairs, fire truck pump tests, aerial certification maintenance, general inspection follow up, Knox Box systems and associated installations, weekly truck inspections and repairs, preplanning for emergency responses, and, air pack and cascade systems service and certifications.

In 2008, the department continued to update and replace equipment with the purchase of new equipment as follows: new power unit for the extrication tools; two electric hose reels; new personal protective clothing; new below grade and above grade rescue equipment; cold



water rescue suits; new clapper valves for operating rural hitch type hose lay; underwater rescue camera; signal extraction pulse CO-Oximeter; K12 rescue vent saw; positive pressure exhaust fan; Forestry chain saw and forestry packs with specialty equipment for dealing with forest fires; GPS units; new hand held spot lights; and, NFPA required Traffic safety vests.

The Fire Department membership in 2008 consisted of seventeen firefighters and one junior firefighter. The department members' certifications consist of the following: 10 Level One certified firefighters; 2 Level Two certified Firefighters; two Career Level certified firefighters; 15 firefighters certified in Incident Command System; 13 firefighters certified in Hazardous Material Operations; 1 firefighter certified as a Hazardous Material Technician; 4 certified firefighters at Inspector One Level; 2 firefighters certified in Confined Space Rescue Work; 8 firefighters certified as Ladder Company Operators; 2 First Responders; 6 firefighters certified at EMT-Basics Level; 1 firefighter certified as an EMT Practical Exam Evaluator; 2 firefighters certified in Emergency Response to Terrorist Incidents and Terrorist Bombings; 17 firefighters certified in dealing with Mass Casualty Incidents; and, 17 firefighters certified in Firefighter Rehabilitation Procedures.

The members of the Center Ossipee Fire and Rescue Department are committed to the safety and success of our community as well as planning and preparing for the future needs of our community. We encourage the public to be a positive part of the team that works hard for the Precinct. We continue to apply for federal grants in an attempt to offset taxes.

As Chief, I would like to thank the command staff and the dedicated hardworking members of the department for consistently going beyond the call of duty. I would also like to thank the Precinct Fire Commissioners office for their hard work and the members of the precinct who continue to support the Center Ossipee Fire & Rescue Department in their mission to continue to protect the community.

FOREST FIRE WARDEN'S ANNUAL REPORT – 2008

What a difference a year can make. Permits were being issued in January of 2007 due to lack of snow, which certainly was not the case this year. With all the snow it looked as though permits wouldn't be needed until June, but somehow all that snow melted and crews responded to several fires by the end of April. The remainder of the year was fairly typical with a brief dry spell during the spring and the remainder of the year was fairly wet. There were over 650 permits issued in Town this year.

Law Brochures are available at the Town Hall. Further information on the laws can be found through the Department of Resources and Economic Development, Division of Forest and Lands at www.nhdf.org.

Please remember that if the ground is not completely covered with snow at least within a 100 foot radius around any brush pile to be burned, then a fire permit is needed. When in question call and ask. If you wish to burn without snow cover, please call the Fire Department in your Precinct. The Department numbers are listed below. Please only leave a message at one Department. These calls are returned by call fire/rescue personnel that are answering emergency calls on a daily basis, so it is recommended to call at least one day before the day that you wish to burn so there is adequate time for your call to be returned and for someone to issue the permit.

OSSIPEE CORNER FIRE DEPARTMENT

ANNUAL REPORT – 2008

The Members of the Department responded to 310 Emergency Calls in 2008. These calls were answered during a year of weather extremes. The year started out with near record snow. Access down private roads and driveways was difficult to impossible at times. Paths and doors were not shoveled wide enough to allow for stretchers. Roofs were not shoveled off, resulting in several building collapses. Somehow all the snow melted without much flooding and things went back to normal, until in July when a tornado tore a path through the Precinct. It came from the south entering the Precinct on Browns Ridge Road, it continued northeast crossing Route 16 by Ted's Discount, then into Granite between White Pond Road and John Hodgdon Road, it continued across White Pond, then across Effingham Road, where it then continued into Effingham. There was severe damage through the entire path and after checking all homes and vehicles involved, miraculously no one was seriously injured. December brought an ice storm which had members out once again assisting residents. Through these extremes this Department demonstrated that it is prepared to respond whenever the call goes out under whatever circumstances.

Crews also responded to several structure fires throughout the year. One of which was to a town landmark known by all as Sunny Villa. Because of the quick response by the number of firefighters and apparatus throughout this town and surrounding towns, the building was saved despite the freezing temperatures, gusty winds and type of building construction.

One of the house fires this year could have had a very different outcome, but the resident was awoken by one of the smoke alarms given out through the Departments "Detect For Life" smoke alarm program. This smoke alarm saved a life. The Department received 1,800 smoke alarms and extra batteries from a grant to distribute. At this time we are out of smoke alarms, but still have batteries to give out. If you are a resident of the Precinct and need or question if you need new smoke alarms or batteries, or if you are not sure that you have enough smoke alarms, please call the fire department at 539-2407.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

The challenge to provide each student with a safe, adequate and appropriate school facility still remains in front of us. During the past three years, the School Board has given voters the opportunity to consider two different plans designed to address the district's long-term facility needs. Their goal has been to address both the space needs issues at the Kingswood complex as well as mitigate the obsolescence that exists in a building that is approaching 50 years in age. In addition to the existing over crowding, the inadequacies in the building include the availability of appropriate space, technological deficiencies, heating and lighting systems that are extremely inefficient and safety/security systems that do not either meet today's codes or are failing due to their age. All of these deficiencies have been recognized by the various jurisdictional agencies and the failure to correct them may lead to a loss of school accreditation or restrictions in the use of the facility.

The revised plan keeps pupils at the schools that the respective age groups currently attend and provides immediate relief to the high school. Most importantly, the plan is designed to take advantage of the narrow window of opportunity that will provide 88.75% state aid for the vocational portion of the project and 55% building aid on the remaining portion of the project.

There are those who question the wisdom of bringing forward a major building program during difficult economic times. First, the School Board believes in the voices of all of the people and the only way everyone has the opportunity to express approval or disapproval is through the voting booth. Second, difficult economic times are ideal for initiating such projects. Interest rates are low and contractors are aggressive in bidding jobs in order to keep their employees working. The same project during good economic times when interest rates are higher and construction companies are busy would likely cost taxpayers multiple millions of dollars more to complete. Additionally, such projects help with an economic recovery. Given the age of the high school, conditions there are not going to improve; they will only continue to deteriorate. Unless one believes that there will never be an economic recovery, it makes sound financial sense to do the project now before costs rise and while substantial state aid money is still available to us. However, both the School Board and I have the upmost respect for the will of the voters regardless of the decision.

Since coming to the Governor Wentworth Regional School District in 1992, I have had the pleasure and distinct honor of working with Dr. Kathleen McCabe. Throughout her tenure here as a dedicated servant to the district, she truly has committed her life to "Helping each child create the future." At the end of June in 2009, her journey as a public school educator will come to an end as she enters a new phase in her Life; retirement. I wish to extend to Kathy my personal thank you for all of her contributions to Governor Wentworth and wish her health and happiness in the years ahead.

In closing, I would be remiss if I failed to thank the employees and the School Board for their unwavering dedication to the children residing in the district as well as the taxpayers who have been generous in their support of our schools.

VNA-HOSPICE

Ossipee Annual Report 2008

VNA-Hospice of Southern Carroll County and Vicinity is in its 8th decade of providing home health care to residents in the Lakes Region. We have 60+ employees and almost twice as many volunteers who work as a team to provide quality home health and hospice care to residents of Ossipee and ten other towns in Carroll County. We are a not-for-profit Agency, governed by local residents and licensed by the State of New Hampshire. Our Home Health and our Hospice Care Programs are Medicare/Medicaid Certified. Our Maternal Child Health Program is Medicaid Certified - all three Programs are licensed by the State and we contract with almost all insurance companies.

We were privileged to provide the residents of Ossipee with services from all three of our programs during 2008. The Agency's staff made 20,000 visits last year. Of those visits over 3,000 were made to Ossipee residents: 2,350 homecare visits, 410 hospice visits, and 382 maternal child health visits.

We had another difficult financial year in 2007; however, we are pleased to report that 2008 was back (slightly) in black. Our quality of care and scope of services have not diminished. In our recent monthly 2008 patient satisfaction survey, conducted by a national company, 97.3% of 188 patients, who returned the survey, were satisfied with our caregivers' services. On a scale of 1 to 5, our scores averaged over 4.75 to the questions: "Would you recommend our agency to others", and "please rate the overall quality of care you received from our agency".

We actively collaborate with other health care agencies in the region, trying to find ways to meet your health care needs. This continues to be a fiscal challenge as Federal, State and private insurance providers try to limit the amount of money spent on health care. The home health care industry will continue to grow as it is a cost effective way of providing quality health care, and the home is often the best place for homebound patients to receive care.

Thank you for your continued support and for allowing us to provide Ossipee residents with needed home health care services.
